- 3. **SUPERINTENDENT AND ADMINISTRATIVE CONTRACTS**- The Board of Education is required to take action on administrative contracts each year on or before April 1. The following recommendations are presented for your consideration:

**Recommendation:** The Board of Education approve the extension and issuance of a three year administrative contract with insurance and salary changes for Mr. Jeff Rehlander as Superintendent of Schools beginning July 1, 2016 and ending on June 30, 2019.

**Recommendation:** The Board of Education approve the extension and issuance of a two year administrative contract beginning on July 1, 2016 and ending on June 30, 2018 with insurance and salary changes for Mr. Terry Breen as the Elementary Principal, Director of Food Supervisor, and District Grants and Reports Administrator.

**Recommendation:** The Board of Education approve the extension and issuance of a two year administrative contract beginning on July 1, 2016 and ending on June 30, 2018 with insurance and salary changes for Mr. Chris Miller as the Director of Athletics, Dean of Students, and Director of Facilities and Grounds.

Recommendation: The Board of Education approve the existing administrative contract beginning on July 1, 2015 and ending on June 30, 2017 with insurance and salary changes for Mr. Phil McAndrew as the Middle/High School Principal and Director of Transportation.
