VI. NEW BUSINESS

1. RESIGNATION OF JULIA BAKER- I, Mr. Kelli Rumery move that the Board of Education accept the resignation of Julia Baker effective June 6, 2019, as Coordinator of Cyber Charter and Shared Services. Motion was seconded by Mr. Ben Baxter.

2. RESIGNATION OF TERRY BREEN- I, Mr. Ben Baxter move that the Board of Education accept the resignation of Terry Breen effective June 30, 2019, as Elementary Principal and District Grants and Reports Administrator. Motion was seconded by Mr. Kelli Rumery. **MOTION CARRIED 6-0.**

The Superintendent requests permission from the Board of Education to establish a nominal daily rate of additional compensation for Marc Kline for these days. Motion was seconded by Mr. Kelli Rumery. **MOTION CARRIED 6-0.**
