2. STUDENT EXPULSION- I, Mr. Ben Baxter move, that the Board of Education expel Student A for 180 school days for violation of the school conduct code. The first day for expulsion being Friday, September 20, 2019, and extending 180 school days. Student A may reapply for reinstatement no sooner than after 150 school days, which would be Friday, May 15, 2020. Motion was seconded by Mr. Kelli Rumery. **MOTION CARRIED 6-0.**
