I. CALL TO ORDER- Board President, Mr. Chris Hancox, opened the virtual regular scheduled open meeting at 7:00 p.m.

III. CONSIDERATION AND APPROVAL OF THE AGENDA- I, Mr. Ben Baxter move, seconded by Mr. Kelli Rumery to approve the agenda as amended moving New Business ahead of the Consent Agenda due to the storm and further moving the New Business items 1. Headlee Rollback Millage Restoration 2. NEOLA Title IX Policies and 3. Tri County Head Start Lease. **MOTION CARRIED 5-0 (Mrs. Erin Phillip and Mrs. Susan Dalton-Akers lost power during this vote)**

IV. NEW BUSINESS

1. HEADLEE ROLLBACK MILLAGE RESTORATION- I, Mr. Ben Baxter move that the Board of Education adopt option 3- 18 mills for 3 years resolution to

restore the mills. Motion was seconded by Mr. Kelli Rumery. **MOTION CARRIED 6-0. (Mrs. Susan Dalton-Akers was without power during this vote).**

2. NEOLA TITLE IX POLICIES-I, Mr. Ben Baxter move that the Board of Education approve the first reading of the Neola Title IX Policy Change. Motion was seconded by Mr. Kelli Rumery. **MOTION CARRIED 7-0.**
3. TRI COUNTY HEAD START LEASE- Enclosed is a copy of the Tri-County Head Start Lease for one classroom within the Gobles Elementary School for the 2020-2021 school year.
